

### ICA defends doctors of chiropractic

The International Chiropractors Association (ICA) has issued a letter to a former legislator from Louisiana regarding a debasing comment on chiropractors used as a quote on an unrelated topic. Garret Graves, who served in the Louisiana House of Representatives until last year, was quoted in a July 27 article by Jack Brook:

"I don't know what chiropractor or palm reader they got advice from on this but – baffling that someone thought this was a good idea."

The comment was embedded in a statement he made regarding the cancellation of a \$3 billion coastal restoration project. The comment was distributed worldwide by the Associated Press. The article, regarding the potential loss of coastal restoration funds from the Deepwater Horizon Oil Spill Settlement Fund, is an important topic which warrants a serious discussion.

In the letter sent by ICA's CEO, Dr. Edwin Cordero, the following comments were provided:

"This quote from you has no place in such a serious discussion and implies that chiropractors lack credibility. Whether provided as a cheap shot at the profession or out of a lack of understanding of the strong evidence-base supporting the safety and benefit of regular chiropractic care, your quote undermines the valuable work of more than 100,000 Doctors of Chiropractic in the United States including the more than 700 in the state of Louisiana.

Chiropractors (Doctors of Chiropractic) are:

- Recognized as Essential Health Care Providers by the US Government.
- Physician level providers in Medicare, Medicaid, DOD and VA.

### the chiropractic Medicare Coverage Modernization Act

Legislation to increase Medicare coverage of chiropractic services is awaiting Congressional action - and will now have to wait a little longer for action as House Speaker Mike Johnson (R-Louisiana) has sent members home until September.

For almost 50 years, Medicare beneficiaries have only been covered for one chiropractic service: manual manipulation of the spine. Lack of Medicare coverage means seniors and other Medicare patients who require services are forced to either pay their chiropractors out of pocket or visit a provider whose standard procedures may involve drugs, or other treatment options that are often unnecessary.

The Chiropractic Medicare Coverage Modernization Act, (H.R.

539 / S. 106) would allow Medicare beneficiaries access to the chiropractic profession's broad-based, non-drug approach to pain management, which includes manual manipulation of the spine and extremities, evaluation and management services, diagnostic imaging and utilization of other non-drug approaches that have become an important strategy in national efforts to stem the epidemic of prescription opioid overuse and abuse. While the bill increases access options for Medicare beneficiaries, it does not add any new services or remove services currently covered under Medicare.

Recent studies show that access to chiropractic care can

### Chiropractors urged to take action


It is vital that federal representative hear about the importance of increased access to chiropractic care. Urge your representative to co-sponsor The Chiropractic Medicare Coverage Modernization Act, (H.R. 1610 / S. 799) and thank them for their support of Medicare patients.

The net positive effect of increasing access to chiropractic services in Medicare is likely to be both real and substantial among Medicare beneficiaries age 65+, resulting in better care outcomes, fewer adverse events, and lower cost of care. Greater availability of chiropractic care reduces costs for spine-related conditions:

- Access to chiropractic care in Medicare can reduce visits to primary care providers by 0.37 million visits, at a savings of \$83.5 million annually.
- Conversely, reduced access to chiropractic services increases visits to primary care physicians (32.3 visits per 1,000) and the rate of spine surgeries (5.5 additional surgeries per 1,000). This equates to an additional expense of \$391 million to Medicare annually.

- Licensed in Every US State.
- Chiropractic Care is a covered service in Medicare, Medicaid, US military and Veterans Administration health care.
- Safety of chiropractic validated through medical malpractice rates that are among the lowest in health care.
- Research including studies conducted by the US Defense Department show benefits of chiropractic care for improved performance, strength, and recovery.
- Studies show that for patients in pain, chiropractic is first line of care, the rate of opioid prescriptions being filled is reduced by at least 50%.
- Workman's Compensation Research Institute Study found chiropractic care was less expensive for on-thejob injuries, and that employees returned to work more quickly."

The International Chiropractors Association, established in 1926 by the developer of chiropractic, Dr. B.J. Palmer played and continues to play a pivotal role in the development of the chiropractic profession. We worked to get state licensure and today to continue to keep chiropractic a drug-free profession. Today our membership is in every US state and 50 countries around the world. Chiropractic is an essential

choice for the 12% of the global population who deal with back pain every year as well as a whole person care approach for people of all ages and all states of health. Chiropractic is about promoting the body's own innate healing capacity and regular chiropractic care.

In the 1960s chiropractors were belittled and attacked by the organized medical community. Several doctors at the ICA filed a federal Sherman Act violation against the American Medical Association (AMA). Seventeen years in the federal courts and in 1987 a federal judge found the AMA guilty of violating antitrust laws by orchestrating a boycott against chiropractors. The court determined that the AMA's actions, including informing members that associating with chiropractors was unethical, constituted an unreasonable restraint of trade. This led to a permanent injunction against the AMA, preventing them from hindering professional associations between medical doctors and chiropractors. The vestiges of the bias created during that decades long attack.

(NTRACTS, n.d.) One Ohio

nursing center paid \$243,000 in penalties for unknowingly employing an excluded nurse, (OIG, 2025) something that could have been prevented with monthly exclusion screening software.

#### Build a "Speak-Up" Culture Before It is Too Late

Many compliance failures result from silence—team members saw something wrong but did not feel safe speaking up. Encouraging early reporting requires more than an open-door policy. It means building a culture of compliance where everyone feels responsible for spotting and reporting concerns.

The white paper emphasizes the importance of anonymous reporting tools, incident tracking, and staff training. Even when a report turns out to be a false alarm, it fosters vigilance and accountability throughout the practice.

# Clinical Compass announces new informed consent publication

## Study reveals variations in informed consent guidance acrossAmerican Chiropractic Board websites

A new <u>study</u> from <u>Clinical Compass</u> has identified significant variations in informed consent requirements for chiropractors across U.S. state, district, and territory licensing jurisdictions. While informed consent has been a standard in healthcare since 1905, this study reveals inconsistency in the implementation of informed consent process in chiropractic care across the U.S.

The objective of this study was to summarize the laws, statutes, and regulations regarding patient informed consent on the websites of from all United States (US) jurisdictional boards governing chiropractic licensure.

The research, which reviewed all 50 states, one federal district, and five U.S. territories, found that most jurisdictions (82%) do not specify a required format for informed consent, and many do not provide detailed guidance on what should be included in the consent process. However, a small group of jurisdictions—such as North Carolina and Oregon—offer more comprehensive recommendations, incorporating key elements of the PARQ framework (Procedures, Alternatives, Risks, and Questions).

Although the study highlights positive steps toward ensuring patients are informed about the risks of chiropractic treatments, it also underscores the need for greater consistency across the country. Many jurisdiction websites still lack clear regulations or guidelines for informed consent, leading to uncertainty and variation in chiropractic practices.

The study calls for concerted efforts to standardize informed consent processes to promote a culture of patient safety and to ensure clearer communication between chiropractors and patients nationwide.

### Chiropractic Future champions reform on behalf of the chiropractic profession

In a bold and unprecedented step to combat regulatory discrimination and restore competition in U.S. healthcare, <a href="Chiropractic Future">Chiropractic Future</a> has submitted three formal comments to the U.S. Department of Justice's Anticompetitive Regulations Task Force. These comprehensive filings spotlight widespread anti-competitive practices that exclude doctors of chiropractic from full participation in federal health systems and private insurance markets, despite clinical effectiveness, licensure parity, and legal recognition.

The comments address systemic violations of provider nondiscrimination law under 42 U.S.C. §300gg-5, critical regulatory barriers within Medicare, and misuse of ERISA preemption by insurers to suppress chiropractic participation. Together, they form a bold and evidence-backed national effort to challenge systemic inequities that continue to restrict reimbursement, limit access, andenable discriminatory treatment of doctors of chiropractic throughout the healthcare system.

"This is not just about doctors of chiropractic. It's about fairness, access, and patient choice in America's healthcare system," said Kristi Hudson, Chairperson of the Chiropractic Future Leadership Committee. "Through this effort, we've drawn a clear line. Discrimination and competitive suppression must be addressed through federal enforcement."

#### **Key Highlights from the Comments:**

**Provider Nondiscrimination (42 U.S.C. § 300gg-5):** Despite legal protections under the Affordable Care Act, doctors of chiropractic continue to face unequal reimbursement, preauthorization barriers, and unjustified network exclusion. These actions are imposed even when chiropractors deliver services within their licensed scope that are billed using the same codes as other providers. These practices suppress competition and block patient access to proven, costeffective care.

Medicare Coverage Disparities: Doctors of chiropractic are federally recognized as "physicians" under 42 U.S.C. § 1395x(r), yet current CMS rules limit Medicare reimbursement to spinal manipulation only. This exclusion applies even to services such as evaluations, diagnostics, and rehabilitative care that fall within a chiropractor's licensed scope of practice. These same services are routinely

reimbursed when performed by other Medicare-recognized providers. This policy restricts patient access, raises costs, and undermines clinical equity.

ERISA Abuse and Market Distortion: Self-funded plans increasingly invoke ERISA pre-emption to bypass state laws and enforce discriminatory benefit designs. These practices allow insurers to reimburse doctors of chiropractic at lower rates, impose arbitrary visit limits, and recoup payments without due process. Such tactics violate fiduciary duties and suppress chiropractic participation in favor of more expensive provider types.

#### A Call to Action for the Profession

This strategic action represents a milestone in elevating doctors of chiropractic to equal footing within the U.S. healthcare system. Chiropractic Future urges chiropractic organizations, institutions, and individual providers to share these filings, engage with federal advocacy efforts, and press for regulatory and statutory reforms that recognize the full value of conservative, non-pharmacologic care.

"We're calling on every doctor of chiropractic and every stakeholder in this profession to see these comments for what they are - a meaningful step toward opening the door to reform," said Marc Abla, CAE, Reimbursement Workgroup Chairperson. "This is Chiropractic Future's opportunity to change the conversation at the federal level."

Chiropractic Future also recognizes the important contributions of other national chiropractic organizations that have submitted comments to the Department of Justice addressing anticompetitive healthcare regulations. The chiropractic profession is strengthened when multiple voices work to expose and challenge systemic barriers. These independent efforts highlight a shared goal of ensuring patients have access to care from all qualified providers, supported by fair and consistent reimbursement policies.

### Bringing chiropractic care to Gambia a life-changing mission

Imagine being the first chiropractor to introduce chiropractic care to an entire country. For Dr. Neema Tillery-Moore, this became a reality on her recent medical mission trip to The Gambia. As part of the Sunu Reew Medical Mission, she combined chiropractic and physiotherapy to serve a population that had never experienced this kind of care before. Her leadership and servant heart are an inspiration, and her display of the power of chiropractic care is truly amazing.

#### The Mission: Healing, Education, and Impact

The goal of the mission was twofold: to introduce chiropractic care and to integrate it with physiotherapy to help patients heal faster. Dr. Neema found herself in an environment vastly different from here in the states. The Gambians healed remarkably fast.

"One adjustment was life-changing for them," she said. Likely, their physical lifestyle, cleaner food, and resilient mindset contributed to their ability to recover quickly. Theirs is a culture of gratitude and positive mindsets, well known as "the Smiling Coast of Africa."

Dr. Neema worked at the teaching hospital in The Gambia, where she collaborated with physiotherapists, medical students, and doctors to integrate chiropractic into their existing treatments. She also conducted a formal lecture on chiropractic care, introducing the field to medical students and healthcare professionals for the first time.





#### A Ripple Effect of Healing

Word about chiropractic care spread rapidly. Within days, she was adjusting patients from all over the hospital, including department heads and influential community members. Many of them had never experienced chiropractic care before but quickly saw dramatic results.

One of the most incredible chiropractic wins was treating babies with brachial palsy—a condition caused by traumatic births where infants couldn't move their arms. With just two precise adjustments—the Atlas and the shoulder—babies regained movement within days.

Another memorable moment was adjusting an elderly man who had been suffering from chronic back pain for over a decade. After one adjustment, he stood up with ease and expressed disbelief at how much relief he felt. Patients who had suffered for years suddenly found themselves painfree, further solidifying the need for chiropractic care in the region.

#### **Media Recognition & National Awareness**

The impact of chiropractic care wasn't just felt within hospital walls—it became a national conversation even before she arrived. The success of her previous visit led to significant media coverage. She appeared on radio and television broadcasts, working with ambassadors and key officials to ensure the community was aware of her visit. This helped spread awareness and excitement before she even stepped foot in the country.

She also planned and executed a large-scale health fair, coordinating a team that provided screenings for hypertension and diabetes to over 90 people in a single day. Held at the property of renowned Gambian musician Sona Jobarteh, the event required extensive planning, including securing translators for five different local languages and working with Gambian medical students to execute the screenings efficiently.

### The Future: A Chiropractic Wellness Center in The Gambia

This mission was not a one-time event. Chiropractic care in The Gambia is here to stay. Plans are in motion for a permanent wellness center that will integrate chiropractic, physiotherapy, and massage therapy. The vision is not just to provide care but to ultimately train local Gambians in chiropractic, making it a sustainable part of the country's healthcare system.

Dr. Neema is already in the process of securing property for this center, with plans to establish it within the next few years. The facility will not only provide treatment but also serve as an educational hub where physiotherapists, students, and medical professionals can learn about chiropractic care.

#### **Expanding the Mission**

Beyond chiropractic, Dr. Neema is organizing a retreat for women entrepreneurs in The Gambia. In talks of collaboration with Fandema, a school dedicated to teaching women STEM skills such as solar panel creation and sustainable energy, the retreat will bring together women business owners from the U.S. and The Gambia to exchange knowledge, empower each other, and provide resources to help Gambian women build sustainable businesses.

Part of this retreat will include a business pitch competition, where Gambian women will have the opportunity to present their entrepreneurial ideas. Winners will receive funding and mentorship to help grow their businesses, furthering the economic development of the region.

#### **A Lasting Legacy**

Dr. Neema's journey to The Gambia was not just about adjustments—it was about empowerment, education, and long-term transformation. Her experience proves that chiropractic care has a huge place in global healthcare, and her efforts are laying the foundation for future chiropractors to continue this work.



### ACA updates coding guidance for CMT evaluation and management

The American Chiropractic Association (ACA) has updated its coding guidance for doctors of chiropractic when providing evaluation and management (E/M) services on the same date as chiropractic manipulative treatment (CMT).

ACA's white paper on the topic, available to members on the <u>ACA website</u>, provides not only added clarity, but also includes scenarios to help providers and payers reach a common understanding of what is expected within clinical documentation to adequately support both the CMT and a significant, separately identifiable E/M service.

"The implementation of the white paper concepts by ACA members aims to mitigate the negative impact on clinical practices that are routinely denied payment for these necessary services. The paper promotes high-value, high-quality, patient-centric health care, consistent with the

high standard set by ACA documentation guidance."

ACA's coding, documentation, and reimbursement aids are made available under the direction of the ACA Health Policy and Advocacy Committee, which includes the association's representatives to the American Medical Association (AMA) CPT® and RUC coding process. 
#### **Process of Integrating Evidence (PIE) Conference**


"Patients today want the option of non-drug treatments to manage their pain, and research and guidelines support that approach," said ACA President Marc Nynas, DC.

### Public health leaders ask court to protect Medicaid beneficiaries including chiropractic care

The American Public Health Association, along with 67 leading deans and scholars in public health and health law, has filed an amicus brief in the U.S. Court of Appeals for the D.C. Circuit in Monte Rose Jr., et al. v. Robert F. Kennedy, Jr., et al. The brief urges the court to affirm a lower court ruling that the federal government violated the law by allowing Indiana to continue to restrict Medicaid eligibility and coverage of services in its Section 1115 demonstration waiver.

The amici argue that the U.S. Department of Health and Human Services and the Centers for Medicare and Medicaid Services (CMS) violated federal law and research standards when they renewed Indiana's demonstration in 2020 and 2023. These decisions allow the state to continue imposing premiums and eliminate retroactive coverage and non-emergency medical transportation services. These restrictions result in the loss of healthcare access for low-income enrollees, according to extensive research.

"These waivers were never meant to be used as a way of taking away Medicaid services from people and their families," said Lynn Goldman, the Michael and Lori Milken Dean of the GW Milken Institute School of Public Health and one of the amici. "Indiana's waiver has resulted in real harm—tens of thousands of people have lost coverage or gone without essential care."

Medicaid coverage for chiropractic care varies from state to state. Chiropractic treatment through Medicaid is nonmandatory, which means that each state decides whether to include it in its coverage.

Twenty-four states cover chiropractic care, and six states don't disclose whether their Medicare plans include chiropractic treatment. Of the covered states, 13 charge beneficiaries a small copayment up to \$3.80 per session for chiropractic treatment.

Eighteen states place limits on the amount of chiropractic care funded through Medicaid, and limitations vary between states. For example, some states limit the number of visits funded per year while others place an annual funding cap on chiropractic treatment per enrollee.

The 3+3 articulation option saves students the cost of one year of tuition by allowing them to earn their undergraduate



# Doctors of Chiropractic work to extend your healthspan

Your Doctor of Chiropractic strives to help you gain a longer, healthier life. Living longer is only ideal if your health is good and you are able to get out and enjoy your "golden years."

Old age and good health often appear to be mutually exclusive paradigms. In Greek mythology, Tithonus was granted immortality by Zeus, but not eternal youth. As he ages, Tithonus laments his progressively frail body and eventually craves his own death. What Tithonus shows us, aside from being careful what we wish for, is the difference between lifespan and healthspan. That is, not just the number of years we live, but how many of those we are healthy for. The key is optimizing for both, and the power is in our hands more than we realize.

Good health often lies in what we ingest daily. We all know fruit and vegetables — especially those free from pesticides — are best, and that a Mediterranean or plant-predominant diet is preferable. Synthetic additives, artificial flavorings, and indecipherable configurations of numbers serving as filler ingredients very likely contribute to poor health outcomes. Eating ultra-processed foods (UPFs) is associated with several cancers, in addition to the known cardiovascular risks of consuming UPFs packed with hidden sugars and fats.

It's not just the ingredients in our food that we need to scrutinize. Some personal care products contain chemicals called xenoestrogens, such as parabens and phthalates. Few of us are immune to the old marketing ruse of displaying cute models with luscious lips or soft, hairless armpits to flog their latest product. Sadly, opting for renowned higher-end brands carrying heftier price tags does not assure healthier ingredients. We know that oestrogenic overstimulation plays a role in breast carcinogenesis. A 2023 study demonstrated that substituting these products with items free of parabens and phthalates reversed pro-carcinogenic gene expression within 28 days, though whether this translates to long-term health benefits remains to be seen. Choosing products without xenoestrogens should lower exposure to hormone-disrupting chemicals — a small step that could support long-term health.

Finally, more good news is that cognitive stimulation can be completely unintentional, yet still beneficial to your brain's healt. Reading has an association with reduced depressive and chronic pain symptoms, as well as combating cognitive impairment. Your job can also prove important. Adjusting for confounding factors, a recent study found that higher cognitive stimulation at work resulted in lower levels of proteins known to be associated with an increased risk of dementia. What you do for a living might make you live longer. Engaging with word or number games daily has been linked to increased energy and reduced depression, and some studies suggest that regular cognitive challenges may even be associated with lower overall mortality risk. Even if you can only bring yourself to do a Sudoku on the odd occasion, it is still prospectively associated with reduced cognitive impairment.
